PLEASE COMPLETE MEMBERSHIP APPLICATION ON OTHER SIDE

By entering into this agreement, all members listed agree to all conditions contained herein, including the payment of applicable fees and amounts. All members must abide by the policies of the Montrose Recreation District (MRD). The use of the MRD facilities is not permitted if payments are not current.

1. Facilities and specific amenities managed by the MRD may be closed to the public due to repair, maintenance or special events as determined by MRD without refund of any pass portion to the members. ***Maintenance includes an annual closure in the fall of up to two weeks.***
2. Members must present their ID cards, which are issued by MRD, to utilize the facility. Lost cards will be replaced at a charge of \$5 per card, per incident.
3. Any misuse of ID cards, including use by a non-member, can result in cancellation of all use of the MRD facilities without refund.
4. Requests for refunds of Membership will be considered only in case of injury, which prevents use of MRD facilities, moving from the area or, in the case of Corporate Members, ending employment with the employer who is a corporate partner after the expiration of your annual pass. Refunds will not be issued for locker rentals, 3 month memberships or punch cards.
5. For payment of passes, members may elect monthly electronic withdrawals or annual passes may be paid in full. There is a 15% discount to pay memberships monthly with auto draft withdrawals (ACH/Debit). Members may elect Electronic Funds Transfer (EFT), using a credit or debit card.
 - a. **These deductions continue for at least one year. After that one year, the deductions will continue and the membership will stay current until the member stops the membership by notifying MRD, subject to any increases in fees.**
 - b. Billing happens on the 5th day of each month. **Accounts that remain unpaid by the 25th of the month will be charged a \$25 late fee.** It is the members responsibility to notify MRD of any changes to credit card, debit or banking information.
 - c. Any payment failing to process will result in suspension of the pass. Patrons with two monthly billings that fail to process will result in membership cancellation. Payment for the months that failed to process will remain due. Patrons that have had 2 failed transactions on a previous pass are required to pay in full for annual passes and no longer be eligible for monthly billing.
6. Adult recreation program registration, facility rentals and annual pass purchases are not allowed when there is a past due balance.
7. **Annual pass contracts are required to have an active pass for at least 12 months following the sign-up date. Early terminations will be assessed, which is as follows: \$100 for family pass, \$75 for dual, \$50 for individual, and \$25 for youth, senior or child watch.**
 - a. The early termination fee may be waived if a medical issue does not allow participation (documented by a note from a physician).
 - b. **Notice of termination must be given via a MRD cancellation form 30 days prior to termination, meaning that cancellation would happen 30 days following the first date MRD is notified of intent to terminate.**
8. All Members enrolling under a Family or Buy One Get One for Half Membership Plan must reside full-time at the same address listed herein.
9. A Family membership must include any four members living in the same household. Other household members living in the same household may be added at an additional cost. Exception: One caregiver may be added to a Family Pass to assist children of family members, seniors or persons with disabilities such as a grandparent, older sibling or child care provider not related to the family. This person does not need to reside in the family home

Waiver of Liability: Montrose Recreation District

I am aware that the use of Montrose Recreation District ("MRD") recreational facilities, equipment and facilities owned, operated or maintained by MRD and participation in any program or activity of MRD (collectively, the "Recreational Facilities and Activities"), are inherently risky and can cause injury. By signing this agreement, I acknowledge that I voluntarily assume all responsibility for any injury, illness, loss, theft, damage to person or property, or other consequences arising directly or indirectly from my use of the Recreation Facilities and/or participation in the Recreational Activities. I agree to indemnify, release from liability, defend and hold harmless MRD, its officers, board of directors, employees, agents, representatives, volunteers (paid and unpaid), and any sponsoring partners, organizations or groups affiliated therewith (collectively, "MRD") for any claims arising from or related to MRD's negligence. Moreover, I agree to assume any financial obligation, either through my health insurance, or through some other means, for any medical costs that I incur. MRD assumes no responsibility for any medical expenses, injury, or damage suffered by me in connection with my use of the Recreation Facilities and/or participation in the Recreational Activities. In the event of injury, I waive my right to bring any legal action, now or at any time in the future, to recover compensation or obtain any other remedy for any injury to myself or my property or for my death, however caused, arising out of my use of the Recreational Facilities and/or participation in the Recreational Activities. I further agree that I, my spouse, assignees, heirs, guardians, and legal representatives will not make any claim against, sue or attempt to attach the property of MRD for any loss or damage resulting from my use of the Recreational Facilities and/or participation in the Recreational Activities.

Code of Conduct and Photography Waiver: Montrose Recreation District

To ensure the safe enjoyment of MRD services, all patrons must exercise respect and appropriate behavior while utilizing MRD facilities and programs. Failure to comply with this code of conduct may result in being asked to leave and/or forfeit the recreation pass.
